SUMMARY EXPLANATION

The Polk County Emergency Management Commission cooperates with the homeland security and emergency management division of the department of public defense. The commission shall coordinate emergency services in the event of a disaster. The City is allowed one representative position and one alternate representative position on the board. Gary Walters, Chief of Police, has been serving as the City's representative and it is recommended that he be appointed to that position again in 2010. Christopher Cross, Fire Chief would serve as the Alternate Representative.

RESOLUTION TO APPOINT A REPRESENTATIVE AND ALTERNATE REPRESENTATIVE TO
THE POLK COUNTY EMERGENCY MANAGEMENT COMMISSION

WHEREAS, the county board of supervisors, city councils, and school district boards of directors in each county shall cooperate with the homeland security and emergency management division of the department of public defense to establish a local emergency management commission to carry out the provisions Iowa Code Chapter 29C; and

WHEREAS, the commission shall be composed of a member of the board of supervisors or its appointed representative, the sheriff or the sheriff's representative, and the mayor or the mayor's representative from each city within the county; and

WHEREAS, the commission members shall be the operations liaison officers between their jurisdiction and the commission; and

WHEREAS, the commission shall meet monthly to determine the mission of its agency and program and provide direction for the delivery of the emergency management services of planning, administration, coordination, training, and support for local governments and their departments; and

WHEREAS, the commission shall coordinate emergency services in the event of a disaster;

NOW, THEREFORE,

BE IT RESOLVED that Gary Walters, Police Chief be appointed as the Emergency Management Commission Representative for 2010; and

BE IT FURTHER RESOLVED that Christopher Cross, Fire Chief, be appointed to serve as the Alternate Representative for 2010; and

BE IT FURTHER RESOLVED that the Representative or Alternate Representative will attend the monthly Commission meetings on behalf of the City of Windsor Heights.
