WHFD staff completed training in the following areas:


- Live fire training at the FAST Center




Type of Alarm Summary Graph
Alarm Date Between {08/01/2013} And {08/31/2013}




WHFD EMS Charges: August 2013

Chief:

I have completed 27 commercial inspections for the month of August. The area of inspection was the University area between 68th and 70th street. The break-down is as below.



In August I billed 6 businesses for violations totaling \$150.00 in inspection fees. Most common violations were fire extinguisher required annual service tag, and emergency lighting required. In addition to inspections, we completed the following:
