## **ISSUE: DART APPONTMENT**

Resolution approving nominees for persons to serve as commissioner and alternate for the Des Moines Regional Transit Authority.

## **BACKGROUND:**

The time has come to reappoint the DART Commissioner and alternate. The Mayors of West Des Moines, Clive and Windsor Heights are recommending to their respective City Councils that the following be appointed as the DART Commissioner and alternate:

Commissioner: Steve Brody-Clive City Council & current Commissioner. Currently he is the vice-chair of the DART Commission

Alternate: Steve Peterson, former City Council member and current alternate

Both Clive and West Des Moines City Councils have approved these appointments. Also several other communities have appointed DART representatives that are not currently elected officials. I offer that in case there are concerns that our proposed representative does not serve on the City Council.

## **RECOMMENDATION:**

The Mayor & staff recommends the City Council approve the recommended appointments to serve as the Clive, West Des Moines and Windsor Heights DART commissioner and alternate.

RESOLUTION APPROVING NOMINEES FOR PERSONS TO SERVE AS  
COMMISSIONER AND ALTERNATE FOR THE  
DES MOINES REGIONAL TRANSIT AUTHORITY

WHEREAS, pursuant to the Amended and Restated Agreement for the Des Moines Regional Transit Authority, the Mayors of Clive, West Des Moines and Windsor Heights shall constitute a Selection Committee for the DART Commissioner and Alternate positions for the DART District comprised of the Polk County portion of State House District No. 42 and District No. 43.

WHEREAS, prior to nominating a person to serve as a Commissioner or Alternate, the Mayors of Clive, West Des Moines and Windsor Heights are first required to submit the proposed nominees to their respective City Councils for approval.

WHEREAS, the Mayors for Clive, West Des Moines and Windsor Heights desire that Steve Brody be approved by their respective City Councils for nomination for a four (4) year term as DART Commissioner and that Steve Peterson be approved for nomination for a four (4) year term as the Alternate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCILS OF THE CITIES OF CLIVE, IOWA, WEST DES MOINES, IOWA AND WINDSOR HEIGHTS, IOWA:

That the nomination of Steve Brody for a four (4) year term as DART Commissioner and Steve Peterson for a four (4) year term as Alternate for the DART District comprised of the Polk County portion of State House District No. 42 and District No. 43 is hereby approved.
