Statistics

Attached are the statistics for the month of APRIL 2013.

Significant Emergencies

- The WHFD assisted The Clive Fire Department on Saturday, April 13, 2013 at 0125 hours with a house fire in the 1200 Block of 108th Circle in Clive. Windsor Heights, Clive, and West Des Moines Fire Departments were at the scene for 3 hours.
- On April 24, 2013 the WHFD and WHPD responded to the Elk's Lodge, for a person with cardiac problems. While units were responding, they were updated with the information that CPR may be in progress. Units from the Windsor Heights Police Department were 1st to arrive, found the victim with no pulse or respirations, and officers placed their AED (automatic external defibrillator) on the patient and delivered 2 shocks to the patient. The first shock was prior to the arrival of the EMS, and the second was just before the paramedics assumed care of the patient. Following the initial care from the PD and FD, the patient regained his pulse and began attempting to breathe on his own. The patient was transported to the hospital for further cardiac care and then released from the hospital.
- On the afternoon of April 25, 2013, the WHFD responded to the 7100 block of I-235 West Bound for a brush fire. Upon arrival a medium sized grass fire was found on the north side of the interstate. A construction crew working for the DOT removing Interstate signs in preparation for the Interstate widening project was cutting a bolt with a rotary saw, when the sparks from the saw ignited the surrounding vegetation. The fire was brought under control quickly with one Engine Company and approximately 500 gallons of water. No construction workers were injured.


